Please read the track regulations before starting the race!

Clothing: Make sure that you wear tight-fitting clothes and that scarfs, ties and belts are safely attached. We disclaim any liability for inappropriate clothing or damage to clothes. If you use one of our rental helmets, wearing of a balaclava is obligatory for hygenical reasons. Purchased tickets will lapse in case of absence at the start or at the same day at the latest and can only be exchanged for a voucher.

Any driver acting with gross negligence or driving without due care and attention will be disqualified from the race. Smoking is prohibited in all areas of the racetrack. Since the conditions on an outdoor racetrack depend on the atmospheric conditions, we ask you to drive the first laps only at slow speed.

Declaration of liability:

With his signature the undersigned declares and accepts expressly that he will enter and walk on the site and in the premises of KART 2000 - SILBERPFEIL and use the technical installations as well as the karts only and completely at his own risk and peril. In particular KART 2000 - SILBERPFEIL shall not be liable for any kind of personal injuries as well as damage to material or property caused to the undersigned or to a third party resulting from his own use of the kart or the use of a kart by a third party. The same goes for all damages caused to the undersigned due to the incorrect behaviour of other drivers or for all damages caused to a third party due to the faulty behaviour or the undersigned.

The present disclaimer of responsibility also includes damages to properties the undersigned brings along with him to the site and in particular to all vehicles which are parked on KART 2000 - SILBERPFEILS's own car park.

In particular KART 2000 - SILBERPFEIL will be held free from any liability regarding liability claims issued against the undersigned by other drivers or visitors as well as third parties due to damages the undersigned has to take responsibility of in connection with the use of the racetrack/karts as well as the passing of the entrance areas to the racetrack.

If the undersigned issues an own liability claim, he waives his right of recourse against KART 2000 - SILBERPFEIL.

The above-mentioned responsibility disclaimers do not include injuries or damages that are caused by KART 2000 - SILBERPFEIL, its employees and delegates by gross negligence or intention. However, if for whatever reason KART 2000 - SILBERPFEIL assumes liability, they can only be held responsible up to the amount covered by their insurance.

Using the kart racetrack requires a high level of concentration and discipline as well as a good physical constitution of the pilotes. The undersigned confirms that he is in good health and that he will not drive under the influence of alcohol, narcotic drugs or pharmaceuticals which can change his driving fitness. We would also like to point out that the participation of persons suffering from cardiac insufficiencies or hypertension can be a considerable risk.

The instructions of KART 2000 - SILBERPFEIL, its employees and delegates have to be followed. The undersigned assumes liability for all damages caused to his kart by himself or by a third party's fault due to an accident, inadequate handling or the none-observance of instructions given by KART 2000 - SILBERPFEIL, its employees and delegates.

The undersigned declares expressly that he has read and understood the track regulations.
